Before a Building Permit may be issued all permit fees must be received by the Village. On large projects the owner and or owners representative and Commercial Construction Trustee, should confer prior too and as soon as possible after the building permit application is made to discuss the scope, cost and schedule of construction and building inspections so as to minimize any inconvenience and expense to the owner.

NOTICE REGARDING ROOFING PERMIT

This notice is being distributed with roofing permits to inform building owners of a key requirement of the Illinois Department of Financial Regulation (IDFPR), which is the state agency responsible for the licensing of roofing contractors.

IDFPR requires all roofing contractors to be licensed by the State of Illinois in order to perform roofing work. This state law does, however, allow building owners do obtain a roofing permit and perform their own work for their own building, but the building owner may not hire the work out to a non-licensed roofing contractor or individual.

This requirement is beneficial to the building owner because in order for a roofing contractor to become licensed in the State, they must meet certain qualification requirements, and must meet guidelines for insurance, bonding, etc.
